| Job Purpose<br>To assist pupils with their day to day personal care needs and to work alongside other professional staff to further pupils' independence skills.   |                           |   |

Assisting pupils in implementing their own personal care programmes during the school day, specifically in relation to practical support for :<ul style="list-style-type: none"><li>Personal hygiene</li><li>Toileting and continence training</li><li>Eating and drinking</li></ul></div> <div>3. Providing practical assistance in relation to other identified physical needs e.g. transportation, dressing, meal times, organisation of learning equipment</div> <div>4. Keeping records related to personal care in conjunction with the appropriate teacher/other officer</div> <div>5. Maintaining and cleaning personal care equipment and materials, clothing etc. Maintenance of toiletry supplies</div> <div>6. Providing personal assistance to identified pupil/pupils in physical/practical activities e.g. physical education, cookery, school visits, therapeutic treatments organised by the school etc</div> <div>7. Working in cooperation with other key workers involved in supporting the pupils' educational and health care needs under the guidance of the class teacher or other responsible officer</div> |                           |   |
